In the event, your account status becomes more than (30) days past due a Mechanic's Lien may be filed with the appropriate county recorder's office. The additional protections provided by the Mechanic's Lien process do not change the customer's legal liability to pay promptly.

**Late Charge:** If the customer does not pay within our published payment terms, the customer agrees to pay Tri-State Materials, Inc. a late charge equal to 1.5% per month (not to be compounded) of the amount remaining delinquent. In addition, a \$25.00 service charge shall be added for checks returned for any reason by customer's bank.

**Collections:** In the event of customer's failure to pay its obligations hereunder in a full and timely manner, Tri-State Materials, Inc. shall also have all other rights and remedies available at law or in equity, including without limitation the right to discontinue providing the Product to customer.

**Note:** Tri-State Materials, Inc. specifically reserves the right to use any or all of the following remedies in the course of collecting amount due to Tri-State Materials, Inc.: Preliminary Notice, Mechanic's Lien, and Joint Check Agreements.

**Confirmation:** Tri-State Materials, Inc. acknowledges receipt of the customer's purchase order via a Sales Confirmation which must be signed by the customer and returned to Tri-State Materials, Inc. prior to placing the order into production. It is the customer's responsibility to review the Sales Confirmation to ensure the accuracy of the order. The Sales Confirmation supersedes the customer purchase order.

General Provisions: All materials are sold F.O.B. Plant Site of Production. Sale is consummated and title passes to Buyer at the time the materials are loaded for shipment. Buyer bears the risk of any loss, deterioration or damage to the materials from the time of loading with the carrier. Delivery is by California Highway Patrol Licensed carriers. Carriers make deliveries at Buyer's risk and Seller assumes no responsibility whatsoever for damages resulting from such deliveries. In the event of any controversy regarding the terms, provisions and/ or conditions of this Purchase Order, Tri-State Materials, Inc. shall be entitled to reasonable attorneys' fees (and, if applicable, court and other costs). Customer hereby consents to the jurisdiction of any court located within the Riverside County, State of California, in the event of litigation. All matters affecting the validity, construction, interpretation and enforcement hereof shall be determined by application of the law and procedures of the State of California.
